The Neighbourhood Plan

Town Councillor Richard Hardcastle writes:

A Town Council Working Group has been developing the Neighbourhood Plan (NP) since 2012. This working group is made up of town councillors and members of the public. It reports to the Town Council's Planning, Licensing and Traffic Committee. It is aided by Directions Planning, a planning consultancy who has experience in the process of creating NPs.

It is important that this is not just the Town Council's plan, it is very much community-led. It results from a wide-ranging set of consultations with residents, businesses and community groups, allowing an evidence-based plan to emerge, the first draft of which was published in October 2018.

Having a NP is useful in several ways: -

- 25% of levies made by Leeds City Council (LCC) on new Horsforth developments will be allocated to the Town Council to be spent on community projects.
- Key elements of Horsforth are protected, (where there is no protection already in place), like some green spaces, special heritage buildings, and new areas are recognised as having their own unique character that is worthy of protection.

The NP does not stop the development that LCC plans for Horsforth in its Core Strategy and Site Allocations Plan. However, it does mould it to try to ensure that any development fits in with the character of the Horsforth area.

After 17th July this year, LCC will submit the NP with all the latest responses / comments to an independent Planning Inspector (PI). The PI ensures the NP is "sound", making a judgement on whether the NP is positively prepared, effective and justified. If the NP is not sound the PI may propose modifications to the NP to make it sound.

Once the NP is deemed sound, LCC will arrange for a local referendum for all Horsforth electors on whether to adopt the plan. LCC would then put the plan to a vote, and if approved, the plan becomes "made" and joins Leeds' planning framework as a statutory planning document. Timing for this may be by the end of 2019 or the beginning of 2020. The life of the plan is 5 years, when it will be reviewed again.

This is a brief description of the Neighbourhood Plan and only hints at the amount of work which has been put into it, principally by ex-councillor Martin Hughes. I must end by thanking Martin for all his efforts on this project. Without his efforts the plan could not proceed.

Purchase of 3 & 5 The Green

Earlier in the year Horsforth Town Council made a commitment to purchase the leasehold for 3 & 5 The Green and The Stables from Leeds City Council.

The Town Council's ambition was to work with Horsforth Live at Home Scheme and to create a community hub within No3 and to protect our volunteer led Village Museum within No5.

The Town Clerk has made the offer to Leeds regarding our purchase of the site and we are now waiting for their legal team to come back to us with the leasehold agreement. We have requested a 125 year lease with no ground rent or any other annual costs payable to Leeds City Council.

We have no plans for any further increases to the council tax precept to fund this project.

No completion date for the project and the new hub is known yet. At this stage we are very dependent on the speed that Leeds City Council operates. Which can at times be frustratingly slow.
