Cllr R Jones gave an update on the airport. In November the airport withdrew night flight applications. Any flights before 11pm do not count as night flights. QC0.5 rated aircraft are permitted to arrive and leave the airport overnight. CEO of LBA Vincent Hodder believes no rules were broken as QC0.5 aircrafts do not count. Evidence will be extended to 18<sup>th</sup> March 2024. It is unclear if the airport may have been sold to another party. Regeneration of the airport terminal due to be complete by January 2025 A good year for profits for the airport, concerns still on going if there is an increase in night flights. Time slots are determined by aircraft owners. The terminal updates will generate 170+ jobs.
